25.100 Public Questions

Are the Parish Council aware of the number of sewage discharges since 29th August?

Although the outlet is in Sandown on the Isle of Wight the Council will write to Southern Water expressing our concern.

Would it be possible for the Shore Road speed limit to be reduced to 15/20 mph during the summer season.

To do this we would have to request a Traffic Regulation Order from West Sussex County Council Highways Team. Prior to this we would have to monitor the speed of traffic on Shore Road over a year and fund a public consultation to ensure the speed reduction has the support of the majority of the community. It is possible however it will take a lot of work. The Council are unsure whether in fact, when the road is busy with pedestrians and parked cars in the summer months reaching a speed of 15mph is possible. The situation will be monitored.

25.101 Minutes of the Previous Meeting Held on 10th July 2025 (appendix 1)

The minutes of the meeting held on 10th July 2025 were agreed as a true record and signed by The Chair.

25.102 Chairman's Announcements

The Chichester District Council Local Plan has now been approved with no housing allocation for East Wittering & Bracklesham.

Condition 22 (regarding sewage) for the Fossil Bay development on Clappers Lane has not been discharged until it has been the properties will not be occupied.

Witterings Place development on Church Road is still waiting for the resolution of the sec 106 regarding social housing.

Thank you to the volunteers and stall holders for attending the Community Picnic. In particular the Clerks without whom it would not have happened.

There is to be a change in the Community Warden covering our areas. Barry Faust will be joining us later this month.

25.103 Update on Actions from Previous Meeting

25.104 Reports from District & County Councillors

PM The Councils are now close to concluding the business case for the government reorganisation with two options, either two or a single unitary council. The preferred option will be determined later this month which must be submitted to government by the 26th September. The government will then review the proposals and initiate a public consultation. Throughout this process, the officers and chief executives of the eight councils have collaborated effectively and constructively.

IB Reiterated how well the councils had worked together on the business case for the government reorganisation. Although the Local Plan has been accepted CDC were only able to demonstrate just over a 5 year land supply this therefore may be challenged. A grant is now available for businesses to help support the night-time economy.

Investments Committee

11th **August** – agreed to drop the minimum holding in the Lloyds account to £25,000. CCLA have slightly increased their charges.

JEB & DH attended– Flu jabs will be taking place in Oct. Residents are being encouraged to use the NHS app. In line with the 10 year plan changes will be made to the process of booking an appointment.

Council AGREED to suspend the Financial Regulation solely for the purpose of the removal and installation of the new bus shelter in Stocks Lane. Due to regulatory requirements and current market conditions, the Clerk has been able to obtain only a single quotation for the required works. Full Council approval will be sought for the exact costings at the meeting held on 9th October 2025.

25.114 <u>To consider submitting an Expression of Interest in the CDC Assets Transfer</u> Programme

Council AGREED to the previously submitted Expression of Interest for Bracklesham Barn and Park and AGREED to submit an Expression of Interest for Kozy Kot.

25.115 To consider contributing to the costs of running The Help Hub

The decision was deferred to the October meeting. The PC requested that a representative from Selsey Community Forum be invited to attend the meeting in October to enable questions to be raised.

25.116 <u>To determine the allocation of funds raised from the tombola at the community picnic</u>

The Council AGREED to allocate the funds to a Christmas afternoon tea for residents.

The meeting went into closed session.
