20.30 To Receive Reports from District and County Councillors: Susan Taylor (CDC) -

Cllr. Taylor gave the following update: CDC will be focusing all of their efforts on supporting the vulnerable members of the community. Residents can still be seen face to face, but this will be by appointment only.

### 20.32 Urgent Matters

Cllr Cox requested that we add a link to a basic infection control video on to the Council website information page so that people who are assisting neighbours can stay safe.

Annette Reeves gave an update on the Good Morning Call Service and how they were responding to the crisis in the short term and what capacity they had – at the moment they are signposting their contacts to support services but do not have the capacity to undertake home visits or tasks.

Simon McGee from the Home Instead care agency added that at present the focus should be on identifying where vulnerable residents are via doctors surgeries, pharmacies, community wardens, etc. to support them in the short term and educating residents to make sure they are keeping safe in their practices when assisting friends and neighbours.
